WHEREAS, the Authority has received bills and claims for the services provided; and


WHEREAS, the Authority has funds on hand to pay the said bills and claims; and

WHEREAS, an emergency existed in the Union City Parking Authority Offices, due to the malfunction of the Parking Authority Office's HVAC system; and


WHEREAS, pursuant to N.J.S.A.40A:11-6 a contract may be negotiated or awarded for a contracting unit without public advertising for bids and bidding therefor, when an emergency affecting the public health, safety or welfare requires the immediate delivery of goods or the performance of services; and

WHEREAS, as set forth by the Parking Authority's Executive Director, in his correspondence dated August 13, 2015, the extreme heat, in conjunction with the malfunctioning HVAC system caused the Authority office to cease operations and overburdened its computer systems, causing a health, safety and welfare concern for Authority staff, residents and property, requiring immediate action to repair the HVAC system at the Parking Authority's Offices,

NOW, THEREFORE, BE IT RESOLVED, the Commissioners of the Union City Parking Authority, in compliance with all Local Public Contract Laws, does hereby ratify and approve the agreement with Lighting Mechanical LLC, of Maplewood, New Jersey, for repair of the Parking Authority's HVAC system, in an amount no to exceed \$49,335.00.
