

2016 AUTHORITY BUDGET RESOLUTION UNION CITY PARKING AUTHORITY

BUDGET

FISCAL YEAR: FROM 12.01.15 TO 11.30.16

WHEREAS, the Annual Budget and Capital Budget for the Union City Parking Authority for the fiscal year beginning, 12.01.15 and ending, 11.30.16 has been presented before the governing body of the Union City Parking Authority at its open public meeting of September 20, 2016; and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$2,521,094, Total Appropriations, including any Accumulated Deficit if any, of \$2,521,094 and Total Unrestricted Net Position utilized of \$0; and

WHEREAS, the Capital Budget as introduced reflects Total Capital Appropriations of \$0 and Total Unrestricted Net Position planned to be utilized as funding thereof, of \$0; and

WHEREAS, the schedule of rates, fees and other charges in effect will produce sufficient revenues, together with all other anticipated revenues to satisfy all obligations to the holders of bonds of the Authority, to meet operating expenses, capital outlays, debt service requirements, and to provide for such reserves, all as may be required by law, regulation or terms of contracts and agreements; and

WHEREAS, the Capital Budget/Program, pursuant to N.J.A.C. 5:31-2, does not confer any authorization to raise or expend funds; rather it is a document to be used as part of the said Authority's planning and management objectives. Specific authorization to expend funds for the purposes described in this section of the budget, must be granted elsewhere; by bond resolution, by a project financing agreement, by resolution appropriating funds from the Renewal and Replacement Reserve or other means provided by law.

NOW, THEREFORE BE IT RESOLVED, by the governing body of the Union City Parking Authority, at an open public meeting held on September 20, 2016 that the Annual Budget, including all related schedules, and the Capital Budget/Program of the Union City Parking Authority for the fiscal year beginning, 12.01.15 and ending, 11.30.16 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the said Authority's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the governing body of the Union City Parking Authority will consider the Annual Budget and Capital Budget/Program for adoption on October 18, 2016.

UNION CITY BOARD OF EDUCATION, SAID PROPERTY COMPRISING BLOCK
213, LOT 28 ON THE TAX ASSESSMENT MAP OF THE CITY OF UNION CITY**

WHEREAS, the Parking Authority of the City of Union City (the "Authority") entered into an Agreement for the Purchase of Real Property, dated on or about October 31, 2015 ("Purchase Agreement") with the Union City Board of Education ("Board") for the purchase of the land and other improvements commonly known as 516 35th Street, Union City, New Jersey, being also designated as Block 213, Lot 28, ("Land Interest") on the tax assessment map of the City of Union City; and

WHEREAS, by Resolution dated October 30, 2015, the Authority approved the Purchase Agreement of the Land Interest for the nominal sum of One Dollar and 00/100 Dollars (\$1.00), recognizing that the purpose of this transaction is to sell this Land Interest along with two (2) other properties, so as to provide the Board with the ability to construct a school facility and multi-level parking deck, on the three (3) properties located between 35th and 38th Street, off of Bergenline Avenue, which is currently being used by the Authority for surface metered parking; and

WHEREAS, pursuant to the terms of the Purchase Agreement and in accordance with discussions with NJSDA and DOE, the Board seeks to acquire title to the Land Interest immediately in order to advance the approval process for the multi-level parking deck; and

WHEREAS, the Authority seeks to transfer the title to the Board of the Land Interest by the delivery and acceptance of the appropriate Deed, whose language properly and adequately conveys title to the Land Interest from the Authority to the Board; and

WHEREAS, sale of the property is authorized pursuant to NJSA 40:11A-6(e),


NOW THEREFORE, BE IT RESOLVED by the Commissioners of the Parking
