

RESOLUTION APPROVING MEMORANDUM OF AGREEMENT

NO. 2017-042

WHEREAS, the Union City Parking Authority (“UCPA”) is an authority of the public service and is, therefore, an “Employer” as that term is used in the New Jersey Employer-Employee Relations Act, as amended, N.J.S.A. 34:13A-1, et seq., and is subject to the terms of the New Jersey Employer-Employee Relations Act; and

WHEREAS, in accordance with the New Jersey Employer-Employee Relations Act, as amended, and the Rules of the Public Employment Relations Commission, the Public Employment Relations Commission certified, on June 1, 2010, that RWDSU Local 108, UFCW (“Local 108”) is the exclusive representative of the full time and regularly employed part time Parking Enforcement Officers for the purposes of collective negotiations and with respect to terms and conditions of employment; and

WHEREAS, the UCPA and Local 108 have negotiated a successor Agreement to the Agreement which expired June 30, 2016; and

WHEREAS, the Acting Executive Director of the UCPA and the Local 108 representative have executed a Memorandum of Agreement setting forth the terms of a successor agreement which commences retroactively to July 1, 2016 and continues until June 20, 2021;

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of the Union City Parking Authority that:


1. The aforesaid recitals are incorporated herein as though fully set forth at length.
2. The Commissioners of the Union City Parking Authority do hereby ratify the Acting Executive Director’s execution of the Memorandum of Agreement with Local 108.

3. The Acting Executive Director of the Union City Parking Authority is hereby authorized and directed to execute the Contract.

4. The Chairman and Acting Executive Director and/ or any other necessary officer or employee of the Union City Parking Authority is hereby authorized to execute any and all documents and to take any and all actions necessary to complete and realize the intent and purpose of this Resolution.


