WHEREAS, the Commissioners of the Union City Parking Authority recognize the need to contract for auditing services for the fiscal month of December, 2016 and fiscal year ending December 31, 2017 and desire to fulfill said need by Garbarini & Co., to perform said auditing services; and

WHEREAS, the Local Public Contracts Law (NJSA 40A:11-1 et seq.) requires that the resolution authorizing the award of contracts for "Professional Services" without competitive bid must be publicly advertised;

NOW, THEREFORE, BE IT RESOLVED, by the Commissioners of the Union City Parking Authority, that the Parking Authority, is hereby authorized to enter into an Agreement with Garbarini & Co. to provide auditing services for the Parking Authority, for a sum not to exceed \$17,500, for the fiscal month of December, 2016 and fiscal year ending December 31, 2017; and

BE IT FURTHER RESOLVED, that this contract is awarded without competitive bidding as a "Professional Service" under the provisions of the Local Public Contracts Law and that a notice of this action shall be printed in the Jersey Journal, as required by law; and

BE IT FURTHER RESOLVED, that this contract is not governed by the pay to play statute, NJSA 19:44A-20.1 et seq., as it is not anticipated that it shall exceed the sum of \$17,500; and

BE IT FURTHER RESOLVED, that a notice of this action shall be printed in the Jersey Journal, as required by law.

WHEREAS, pursuant to the Local Public Contracts Law, the Authority is required to obtain two written price quotes for said goods and services; and


