



Whereas, N.J.A.C. 5:31-2.5 provides that the filing of the budget may be authorized by the Director of Local Government services, upon resolution of the submitting Authority, setting forth the reasons for the delay; and

Whereas, the Authority had scheduled a meeting of the Board of Commissioners for October 26, 2021, to introduce the 2022 budget, however, due to a serious storm, and out of concern for its Commissioners, its staff and the public, the Authority cancelled its meeting and it was not able to reschedule another meeting before November 1, 2021; and

Whereas, for all the foregoing reasons, the Year 2022 Budget of the UCPA which was introduced by the Commissioners of the UCPA at its November 16, 2021 meeting could not be presented to the Board of Commissioners prior to November 1, 2021.

Whereas, the UCPA's Year 2022 budget cannot be adopted until reviewed and approved for adoption by DLGS; and

Now Therefore Be It Resolved, that the foregoing reasons for delay be made known to the Director of Local Government Services, on behalf of the Union City Parking Authority,


Be It Further Resolved, that the Board of Commissioners of the Union City Parking Authority respectfully requests the Director of Local Government Services to approve the late filing and adoption of the Parking Authority's budget for Year 2022.

RESOLUTION AUTHORIZING PAY/BENEFIT ADJUSTMENT

WHEREAS, the Collective Bargaining Agreement with the union representing the parking enforcement officers, has been finalized providing for a dollar an hour increase in pay for covered employees, for each year of the contract, as set forth therein, and an additional one time increase for covered employees having five (5) or more years of service, with an employee receiving \$1.25, per hour, for five years of service and each employee receiving an addition \$0.25 per hour, for every additional year of service beyond five years, to a maximum of \$2.50 per hour increase and for additional vacation time; and

WHEREAS, it is the desire of the Parking Authority to provide the same increase and vacation to the non-union staff,

NOW, THEREFORE, BE IT RESOLVED, by the Commissioners of the Union City Parking Authority, that the foregoing recitals are incorporated herein; and
